SALES CONTRACT, SPAY/NEUTER CONTRACT & HEALTH WARRANTY

BREEDER RESPONSIBILITY _____ (Buyer's Initials)

Seller guarantees at time of pick-up said dog is healthy. Buyer is required to have puppy examined by a veterinarian within three (3) days verifying the good health of the dog. Should dog be found to be in poor health of a serious nature, Seller will immediately refund purchase price to be sent upon both the return of the dog and the report issued by the examining vet. Any request to return the dog to the Seller for a FULL refund must be made within this time period and only if dog is seriously ill. Buyer may, in lieu of a refund, return dog and receive a puppy from the next available litter (breeder's choice). This guarantee will be terminated immediately if dog is not examined within allotted time (3 days).

BUYER RESPONSIBILITY _____ (Buyer's Initials)

Buyer agrees to pay purchase price of \$3000.00 in full PRIOR to pick-up/delivery of dog described above.

Buyer agrees to maintain dog in good health including routine inoculations, safe parasitic control. Using COMFORTIS, TRIFECTIS, NEXGUARD, or BRAVECTO FLEA & TICK products or any oral flea & tick product, will **VOID** this warranty as they have been associated with serious illness and death. Buyer agrees not to have the LEPTO vaccine given within two (2) weeks prior, or two (2) weeks after any other vaccine or chemical is given. It is also highly suggested the Rabies vaccine be given at 6 months and with no other vaccines/chemicals given at the same time or within 3-4 weeks of administering it. Additionally, the Lyme vaccine may not be necessary unless dog resides in or visits highly infected areas. Please do your research and discuss with your veterinarian. Good health also includes: responsible grooming and coat maintenance, maintaining dog at a healthy weight, providing safe indoor living quarters and a reliable fence. Buyer agrees to limit any strenuous or repetitive jumping exercise, or extended running in the first year of life as this can be detrimental to bone development and contribute to hip dysplasia. If any preventative care has not been provided, health warranty will be void.

Buyer agrees to comply with Seller's requirements for a successful companion which means being properly socialized and providing proof of effort being made to ensure successful training of dog. This includes one or more of the following: completion of two (2) full courses (not classes) of puppy/dog obedience classes before the dog's first birthday, board and train, or one-on-one sessions with a dog trainer.

If at any time in its life the puppy is to be sold or given away, the Buyer agrees to notify Seller and give first option to take puppy/dog back. If Seller places puppy with a new family, any amount of refund to Buyer will not exceed 50% of purchase price, less reservation fee, less any reasonable expense for transportation, veterinary care, grooming, and advertising expenses. There is no guarantee of any money being refunded to Buyer. Seller's primary interest is in the health and well-being of every puppy/dog produced or cared for by Bolingo Labradoodles.

Upon execution of this contract all veterinary care and its associated costs are the sole and exclusive responsibility of the Buyer. It is recommended Buyer purchase a quality animal health care plan to help defray routine or emergency veterinarian costs. Bolingo Labradoodles liability for any health, temperament, emotional, structural or genetically perceived issue is limited to the cost of the puppy/dog (\$3000.00).

GENETIC HEALTH WARRANTY _____ (Buyer's Initials)

A warranty against Hip Dysplasia (HD) is provided for two (2) years from date of birth. The guarantee for HD will be terminated should dog be allowed to become overweight by documented veterinary standards, or be involved in any physical trauma that could cause lameness or injury of any type or duration. Should dog be found to have debilitating HD within its first two years, Buyer must provide Seller with proof in the form of a Penn Hip Report.

A warranty against Progressive Retinal Atrophy (PRA) is provided for two (2) years from date of birth. A diagnosis of PRA must be determined by two (2) certified veterinary ophthalmologists providing Seller with an official report.

Seller reserves the right to have a veterinarian of our choice confirm any results before a replacement, a 50% refund, or surgery for correction (limited to ½ the purchase price of the puppy/dog) is made. Please note, if surgery is chosen Bolingo Labradoodles will pay said amount directly to the vet performing the operation.

LIMITATIONS OF CONTRACT _____ (Buyer's Initials)

Under no circumstances will a refund be made because a dog did not fall within a size category, color or coat type. Every attempt is made to accommodate Buyer's personal preferences in dog's appearance; however, health and temperament are primary. We have no control over hybrid canine genetics.

There is no warranty regarding skin/food/environmental allergies as Seller has no control of the area your dog may be in, the food you choose to feed, or the places you go. Allergies in dogs (like people) can develop at any time.

Under no circumstances shall Seller be liable to Buyer or to any third party for a dog which has been subjected to abuse, accident, negligence or misuse. Also, under no circumstances shall Seller be liable for any consequential incidental or special damages resulting from or in any manner related to the puppy/dog.

Warranty applies to original purchaser only. Transfer of ownership voids all provisions of this agreement.

SPAY/NEUTER AGREEMENT _____ (Buyer's Initials)

- Proof of spay/neuter must be received by Bolingo Labradoodles on or before _____, and within seven (7) days after surgery. Documentation must be in writing from the vet that performed the surgery.

- It is the responsibility of the Buyer, not the veterinarian, to ensure that Bolingo Labradoodles has received this verification.
- Buyer agrees DOG will not produce a litter of puppies either as purposely bred or by accidental breeding.
- Buyer agrees this spay/neuter contract constitutes the first and final notice of the spay/neuter requirement and no further notice is required to institute legal action for violation of the terms of this contract. All fees (legal and investigative) accumulated from enforcing this contract will be sole obligation of the Buyer.
- Failure to comply with this agreement by the above date, unless otherwise agreed to in writing, will be considered a breach of contract and Buyer will transport said dog back to Bolingo Labradoodles. No refund will be given.

FULL AND FINAL AGREEMENT

Both parties agree this writing represents the entire agreement between them and that no other representations, oral or written, have been made regarding the dog described above. The parties further agree no changes in this contract shall be binding upon either of them without written modifications signed by both parties.

Permanent ownership of said dog is contingent upon Buyer's compliance with this contract in its entirety.

Buyer agrees that he/she understands contract fully.
